## 2015 New Orleans Investiture Ceremony

The 2015 Investiture Ceremony convened in New Orleans on November 7-9 at the Astor Crown Plaza in the French Quarter. The liturgical ceremonies were conducted at the Church of the Immaculate Conception on Saturday and Sunday. This year began the change in the Order's awarding of promotions and the investing of new members. Both the Promotion Ceremony on Saturday and the Investment Ceremony on Sunday were conducted before the start of the Masses. Vice-Governor General Patrick Parker was present for the weekend and delivered a report on the Holy Land during the General Meeting. We hosted 13 bishops and many Clergy Knights, some of whom were invested into the Order, joining a growing number of Canons of the Order.

The Archdiocese of Miami Section welcomes Reverend Michael Davis, KHS pastor of Church of the Little Flower in Coral Gables, along with Dame Maria A. Fuentes, LHS and Dame Ana Maria Li-Rosi, LHS into our ranks.

All bring special talents to the Order, including their sense of deep spirituality. We also welcome Monsignor James Dixon, KHS who, although a priest of New Orleans, has been in residence at St Anthony for some years.

The Vigil Service on Friday afternoon created a wonderful foundation for the Investees. The program consisted of several thoughtful readings which were afterwards accompanied by reflective music before the next set of readings. The program provided an excellent spiritual prologue to the coming weekend.

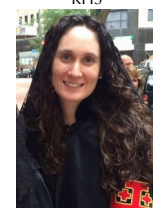

Victorious in Malá Strana, Prague, Czech Republic wherein is housed the Infant of Prague. The Infant Jesus of Prague is a 16th-century Roman Catholic wax-coated wooden statue of child Jesus holding a globus cruciger. The history of the Infant Jesus of Prague started in the 17th century when a statue of the Infant Jesus was brought into Bohemia (now Czech Republic) and eventually was given to the Discalced Carmelites in Prague. Since then, the statue has remained in Prague and has drawn many devotees worldwide who go and honor the Holy Child. Graces, blessings, favors and miraculous healings have been received by many who petitioned before the Infant Jesus.

### Nostra Aetate

The Archdiocese of Miami, the American Jewish Committee, and St. Thomas University hosted a reflection on the 50th anniversary of Nostra Aetate on the campus of St. Thomas University. The Order was invited by the moderator, Monsignor Terence Hogan, KCHS based on our interest and mission in the Holy Land. Nostra Aetate is a declaration on the relation of the Church to non-Christian religions that was proclaimed by his Holiness Pope Paul VI on October 28, 1965.

Nostra Aetate states, in part: "In our time, when day by day mankind is being drawn closer together, and the ties between different peoples are becoming stronger, the Church examines more closely her relationship to non-Christian religions. In her task of promoting unity and love among men, indeed among nations, she considers above all in this declaration what men have in common and what draws them to fellowship..."

The order was represented by the Section President, Sir Bernard W. Wolff, and Dr. David Osterberger, KHS at the November 5, 2015 event.

Below, you will find a few highlights from the 2015 Council Meeting held in New Orleans prior to this year's investiture ceremony. The Council meets every six months to conduct the business of the Order.

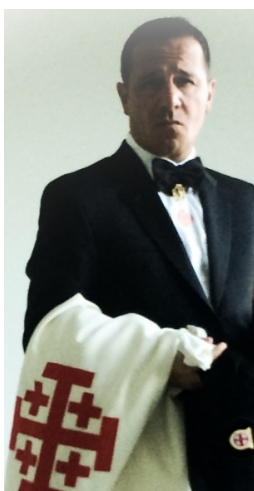
Sir Patrick Powers, Vice Governor General addressed the group and explained that the Holy Father has called for an Extraordinary Year of Mercy. It will be an amazing year as Pope Francis has designated priests who will be given extraordinary facilities to forgive sins not ordinarily forgiven at that level. It will create opportunities to encounter people of the Jewish and other non-Christian faiths in respectful dialogue. It will promote a great opportunity to reach out to fallen away Catholics. He encouraged each member to do works of mercy during this year and make the Year of Mercy a focus in our sections and in our Lieutenancy.

Sir Patrick continued by reporting that the Columbus Hotel progress is still slow. They are waiting for a decree from the court system in Italy, but once it is received they can begin renovations.

Monsignor Hedrick gave a report regarding liturgy and the new requirement to move the promotion and investiture ceremonies before the onset of Mass. This will clarify the importance of the Sacrament. Monsignor asked that when hosting sections are reviewing Churches for their services, that they choose a church with a large sanctuary.

Sir Jim Myers will be creating his last newsletter issue following this meeting. He is retiring and turning the responsibilities over to Dr. Dan Wagner. Ray thanked Jim for his work and Jim was commended by all present.
